- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared on the Inter-American Development Bank, issue no. IDB-00001-GPN of 7 April, 2025.
- 2. The Government of the Cooperative Republic of Guyana has received financing from the Inter-American Development Bank (IDB) as the Administrators of resources for the Department of Foreign Affairs, Trade and Development of Canada (DFATD) and the Government of Canada towards the cost of an Investment Grant, "Support to Safety Nets and Gender Empowerment in Guyana" and it intends to apply part of the proceeds of this financing to payments under the Contract for the Procurement of Forensic Interviewing Equipment for the Ministry of Human Services and Social Security SSNGE 2025 G1.
- 3. The Project Executing Unit (PEU) of the Support to Safety Net and Gender Empowerment in Guyana now invites sealed bids from eligible and qualified bidders for the procurement forensic interviewing equipment- visual stress analysis and layered voice analysis systems for the Ministry of Human Services and Social Security. The delivery period is 180 days.
- 4. The Request for Bids will be conducted through the International Competitive Bidding (ICB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Works and Goods financed by the Inter-American Development Bank GN-2349-15, and is open to all bidders from Eligible Source Countries as defined in the Policies.

manufactured domestically <u>shall not</u> be applied. All bids must be accompanied by a duly completed and signed bid securing declaration form. Additional details are provided in the Bidding Documents.
